NORTH FERRIER PIPELINE COMPLETED ON SCHEDULE AND ON BUDGET

November 2023 estimated production averaged 9,454 boe/d. Volumes were comprised of 70% natural gas and 30% total liquids. The decrease in production compared to October production is the result of natural decline and routine downtime across all areas.

Work on the North Ferrier pipeline continued throughout November. We are happy to report that the project was completed on schedule and on budget and the pipeline was brought into service in mid-December. The addition of this strategic infrastructure supports the continued development of our North Ferrier assets, provides a lower cost structure and will also allow us to realize the full value of our Ferrier processing facility.

Completion operations in North Ferrier started in early December to align with the pipeline coming on stream and the new wells began flowing through the line prior to the end of the of the year. Drilling commenced on a new pad site in Ferrier in late December and we expect those operations to continue throughout January. We look forward to providing updates on the results of recent drilling activity and the overall 2023 capital program in upcoming reports. We are in the process of finalizing our 2024 capital budget and guidance and anticipate providing those details in the coming weeks.
